Using Information under this Open Data License:

- Use of any Information indicates your acceptance of the terms below.
- The City grants you a worldwide, royalty-free, perpetual, non-exclusive license to use the Information, including for commercial purposes, subject to the terms below.

You are free to:

 Copy, modify, publish, translate, adapt, distribute or otherwise use the Information in any medium, mode or format for any lawful purpose.

You must, where you do any of the above:

 Acknowledge the City as the source of the Information by including the following attribution statement:

"Contains information licensed under the Open Data License - City of Chilliwack."

 The terms of this Open Data License are important, and if you fail to comply with any of them, the rights granted to you under this license, or any similar license granted by the City, will end automatically.

Exemptions:

This Open Data License does not grant you any right to use:

- personal information, as defined in the Freedom of Information and Protection of Privacy Act;
- third party rights the City is not authorized to license;
- the names, crests, logos, or other official symbols of the City; and
- Information subject to other intellectual property rights, including patents, trade-marks and official marks.

• This Open Data License does not grant the user any right to use the Information in a way that suggests any official status or that the City endorses you or your use of the Information.
